## Results of 2011 Presidential Election

The High Commission for the Republic of Cameroon wishes to inform the public and especially Cameroonians living in the United Kingdom that results of the recent presidential election were made known by the Supreme Court, acting as the Constitutional Council in Yaounde on Friday October 21, 2011.

Out of the 23 candidates H.E. Paul BIYA of the Cameroon People's Democratic Movement (CPDM) was declared overall winner of the October 9, 2011 presidential election, with 77.989%. He was followed by Ni John FRU NDI of the SDF with 10.712%; GARGA HAMAN ADJI of the ADD with 3.211%; Adamou NDAM NJOYA of UDC with 1.733%; AYAH Paul ABINE of PAP with 1.264%. The 18 other candidates obtained less than 1% each. (See table of results below).
